

## EDITORIAL GUIDELINES

The articles can be written in Italian, or English. The editors reserve for themselves the right to translate them into Italian, having previously informed the author.

The texts cannot exceed the length of 9,000 words (including notes and bibliography) for the articles submitted for publishing in the Studies section, 4,000 words for the bibliographical surveys and 1,500 words for the reviews.

Texts must not have been published previously.

The authors are kindly requested to follow the editorial guidelines below and not to exceed the accepted length. All texts that not abiding by our editorial guidelines or exceeding the length of 9,000 words will not be taken into consideration for publication.

The texts, in Microsoft Word or Open Office format (doc, rtf o odt), must include on a separate sheet a short biographical sketch of the author and a 100-word abstract; three to five keywords must be indicated. In order to guarantee the scientific character of the journal, all prospective publication will make use of a peer review system.

The journal is published on a six-monthly basis. The submission deadlines for the articles due to be published in the June issue is the end of February, while for those due to be published in the December issue the deadline is the end of August.

### Text characters

Title of the article: Garamond, size 12, bold, centered

Titles of the paragraphs: Garamond, size 12, centered

Abstract: Garamond, size 10, justified

Keywords: Garamond, size 10, centered

Body text: Garamond, size 12, justified

Notes (at the foot of the page, progressively numbered): Garamond, size 10, justified

Bibliography: Garamond, size 12, justified

### Capital and lower-case letters

The use of capital letters in general is not advisable; however, it is advisable to use capital letters in cases such as the following:

- international organisms: United Nations, European Union, Komintern;
- states and regions: Italy, Soviet Union, United States of America, Illinois, Cantabria, Normandy;
- institutional organs: Ministry of Foreign Affairs, Royal Navy, Tribunal Constitucional de España, Cortes de Aragón, Diputación Provincial;
- parties and political organizations: Partito Comunista Italiano, Section Française de l'Internationale Ouvrière, Acción Republicana;
- trade unions or syndicates: Confederazione Generale Italiana del Lavoro, Confindustria, Comisiones Obreras, Unió de Rabassaires; Centro Industrial de Vizcaya;

- public agencies and private associations: Istituto Nazionale di Statistica, Cassa del Mezzogiorno, Associazione Nazionale Partigiani d'Italia, Azione Cattolica, Instituto Nacional de Previsión, Banco de España;
- cultural institutions: Università degli Studi di Bari, International Institute of Social History, Archivo General de la Administración, Fundación de Investigaciones Marxistas;
- geographical terms: the South, Middle East, Cono Sur, Levant;
- important epochs and historical periods: the French Revolution, Resistenza, Guerra Civil, Transición;
- official documents: Constitution, Fuero del Trabajo, Magna Charta;
- nicknames and pseudonyms: il Duce for Benito Mussolini, el Caudillo for Francisco Franco, Comandante Carlos for Vittorio Vidali, el Campesino for Valentín González González.

### Abbreviations

Abbreviations must be in capital letters, without any punctuation marks.

E.g. PCI, DC, PCUS, PNV, ETA, SPD, CGIL, IRI, INE, etc.

### Citations

In the body text and in footnotes citations must be delimited by angle quotes (« »).

E.g. Article 1 of the Italian Constitution states that «L'Italia è una Repubblica democratica, fondata sul lavoro. La sovranità appartiene al popolo, che la esercita nelle forme e nei limiti della Costituzione».

Citations longer than four lines must be in a block, size 10, without angle quotes.

In case of *omissionis* in citations, please use suspension points between square brackets [...].

### Bibliographical format for references

In the body text or in footnotes please indicate only the surname, the year of publishing and the number of the page(s) quoted.

E.g. Hobsbawm (1990: 124).

In the appendix there must be a bibliography with all the volumes and articles quoted in the text in alphabetical order. In case there are two or more works by the same author in the same year, they must be distinguished alphabetically (e.g. 2000a, 2000b, 2000c).

Here are some examples:

#### 1. Monographs:

Hobsbawm E. J. (1990), *Nations and Nationalism Since 1780*, Cambridge University Press, Cambridge.

#### 2. Collections of essays:

Álvarez Junco J. (1998), «La nación en duda», in Pan-Montojo González J. L. (ed.), *Más se perdió en Cuba. España, 1898 y la crisis de fin de siglo*, Alianza, Madrid.

#### 3. Scientific journals articles:

Gentile E. (2000), «La nazione del fascismo. Alle origini della crisi dello Stato nazionale in Italia», *Storia contemporanea*, n. 6, pp. 833-887.

### **Archival and press sources**

In the first citation reference please indicate in full and abridged form the name of the archive, fund or section, specifying the number of the corresponding envelope, file or microfilm. In the following quotations please use only abbreviations.

E.g. «Riunione d'informazione del PCI, Parigi, 4 maggio 1938» in Archivio Centrale di Stato (ACS), Ministero dell'Interno (MI), Direzione Generale della Pubblica Sicurezza (DGPS), Divisione Polizia Politica (DPP), Materia, b. 109, f. 5.

In case of press articles, please follow this example:

Di Vittorio G., «Lo spettro della guerra e l'emigrazione italiana», *La Voce degli Italiani*, 27-III-1938.

Arana S., «Las pasadas elecciones (conclusión)», *Baserritarra*, 30-V-1897.
